Packard in consideration of the sum of One Dollar, to me (or us) in hand paid, and other valuable consideration at and before sealing and delivering thereof, by the South Carolina Highway Department, receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell, and release, unto the said South Carolina Highway Department, its successors and assigns, a right-of-way for the construction of a section of the State Highway from N. Main Street (City of Greenville) Name of Place. to Super Highway (City of Greenville) Name of Place. on Route No.

State and County aforesaid, as shown by plans prepared by the State Highway Department, on and over all lands which I (or we) may own in whole or in part, for the purpose of locating, constructing, improving, and maintaining the above described highway with the bridges and causeways thereon.

Bounded by lands of Fannie C. Norwood, Tr. on the west and Lillian W. McGee on the east. Show only the Land Owners along the Highway.

Said right-of-way to have a width exclusive of the old road and ditches of _____feet, that is _____feet on each side of the center line of the Highway except where a greater width is necessary for short distances on account of large cuts or fills.

"Special Provisions:" The only purpose of this right of way is to give to the South Carolina Highway Department the right to reconstruct a retaining wall along the front of my lot.
