East by C. R. Stone, west by Miller St. Bounded by lands of Show only the Land Owners along the Highway Said right-of-way to have a width of x feet, that is 45' feet on sack side of the center line of the Highway except where a greater width is necessary for short distances on account of large cuts or fills.

It is agreed that buildings, fences, signs or other obstructions will not be erected by me (or us) my heirs, assigns, administrators within the limits of the right-of-way herein conveyed, and that such buildings and fences as are now within the limits of the right-of-way herein conveyed will be moved from the right-of-way and restored in as good condition as before moving at the expense of the State Highway Department of the State of South Carolina.

TO HAVE AND TO HOLD, all and singular, the said right-of-way and the rights hereinbefore granted, unto the said South Carolina State Highway Department, its successors and assigns forever.
