All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Gantt Township, School District 6-E, being known and designated as the northern part of Lot No. 14, of Block D, of the property of Julia D. Charles, as shown on plat thereof recorded in the R.M.C. office for Greenville County in Plat Book E, at page 209, and having the following metes and bounds, to-wit:
