WORSHAM all those certain lots, pieces or parcels of land situate, lying and being in said state and county, about three and a quarter miles southeastward from Greenville court house, between the Augusta Road and Reedy River, south of the Greenville Country Club golf course, having a frontage of approximately one hundred eleven and three tenths (111.3) feet, more or less, on the northwest side of Broodside Way, composed of lots 75, 74, 73 and that portion of lot 72, northwest of a straight line, drawn from a point at the joint front line of lots 71 and 72 to the joint rear line of lots 72 and 73, having the following metes and bounds:
