The within conveyance is subject to the existing easements for operation and main-
tenence of power lines, sewer lines and water lines with the right of entry for the purpose of

2. No hogs or cows shall be kept on said premises.
3. No use of said property shall be made which would constitute a nuesance or
annoyance to other property owners in Wildwood Park.
4. No liquor shall be made or sold on said premises.
5. The Grantee shall make a sanitary disposal of sewerage refuse and shall not
empty same into creeks or streams.
The within grantors, their heirs or assigns shall not be liable to the within grantee,
his heirs or assigns for any claim of damages resulting from the operation or maintenance of
any roadways, swimming pool, parks or play grounds or utilities within Wildwood Park Area.
These restrictions are not intended as conditions subsequent but for the protection
of property owners of Wildwood Park, any of whom shall have the right for their protection to
institute necessary proceedings to enjoin and enforce compliance with same.
The Grantors herein do hereby grant and convey unto the grantee, her heirs, the right
and privilege of using the roadway now in existence from the property herein conveyed to the Old
County Road running through Wildwood Park, for the purpose of ingress and egress.
