BEGINNING at an iron pin on the North side of McMakin Drive at joint front corner
of Lots 88 and 89 and running thence along the North side of McMakin Drive, S. 79-28 W. 150
feet to an iron pin at the Northeast corner of the intersection of McMakin Drive and Christopher
