Patterson, of said County, in the State aforesaid in consideration of the sum of Two Thousand Five Hundred and no/100 dollars (\$2,500.00) to me in hand paid at and before the sealing of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto Otis P. Moore All that certain lot, piece, or parcel of land situate, lying and being in said state and County, about three and a quarter miles southeastward from Greenville Court House, between the Augusta Road and Reedy River, south of the Greenville Country Club Golf course, described as follows:

Beginning at the joint corners of Lots one (1) and two (2) on the south side of Riverside Drive, and running north 73 E. a distance of one hundred seventeen (117) feet to a point on the front line of lot two (2); thence, running south 23-48 E. a distance of approximately three hundred fifty three (353) feet, more or less, to a point on the rear line of lot two (2); thence along the rear line of lot two (2), S. 73-0 W. a distance of one hundred seventeen (117) feet to the joint corners of lots one (1) and two (2), on the north side of Club Drive; thence N. 23-48 W. a distance of three hundred fifty three (353) feet to the point of beginning. \(\)
