BEGINNING at a stake in the southerly margin of Northern Street 100 feet North 47-32 West from the near corner measured along Northern Street, of the land conveyed to H. B. McCoy and G. P. Campbell by deed of the Piedmont and Northern Railway Company, dated December 31, 1945; thence South 42-28 West 138.83 feet to a stake 7.5 feet from the center line of the service track of Piedmont and Northern Railway Company; thence North 46-49 West 7.5 feet from and parallel with the center line of said service track 75.05 feet to a stake; thence North 42-28 East 137.9 feet to a stake in the southernly margin of Northern Street; thence South 47-32 East with the southerly margin of Northern Street 75 feet to the point or place of the BEGINNING.
