NOW, therefore, this instrument of writing witnesseth:

That I the undersigned Lila Stribling Doyle hereby declare and affirm the said Tamassee D.A.R. School and Oconee County Hospital to be the beneficiaries choosen by me as the charitable institutions, each to share equally in any balance of the real and personal property, aforesaid, belonging to the estate of the said William R. Doyle, testator, at the time of my death, as provided in his last Will and testament.
