O. Patterson to John Anthony Keys on September 15, 1937, by deed recorded in the office of the Register of Mesne Conveyances for said county in Book 200 page 40, and conveyed by said J. A. Keys to said M. O. Keys on January 14, 1938 (Deed Book 201, page 331), said beginning corner being on the northwest side of Clarendon Avenue, 545 feet southwest of the corner of the land formerly belonging to Mrs. Mattie E. James, then to J. Lee Greene, now to J. Fred Jay and Annie S. Jay (Book 289, page 14), and running from said beginning corner along said Clarendon Avenue N. 46-30 E. fifteen (15) feet to a stake; thence N. 43-30 W.
