Ferguson, all those certain pieces, parcels, lots or tracts of land lying, situate and being in the City of Greenville, State and County aforesaid, and having the following metes and bounds:

TRACT 1: BEGINNING at a point on the southeast corner of Wardlaw Street and a 10-ft. alley, which alley extends in an easterly direction from said Wardlaw Street, 170 feet south of the southeast corner of Wardlaw Street and Rhett Street, and running thence in an easterly direction with said alley 23.8 feet, more or less to lot of Mary Alice Ferguson Wood; thence with Mrs. Wood's line in a Southernly direction 10 feet; thence in a straight line parallel with Pendleton Street 23.8 feet, more or less, to Wardlaw Street; thence along the eastern side of Wardlaw Street in a northernly direction 10 feet to the point of beginning.
