Williams, Jr. and Augusta W. Watson (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ben S. Williams, Jr., and Augusta W. Watson, their heirs and assigns, forever:

(1) All that certain parcel or lot of land situate in Paris Mountain Township, Greenville County, State of South Carolina, lying South of Trowbridge Avenue, and having, according to survey of the property of H. R. Stephenson, made by Dalton & Neves, Engineers, February, 1932, the following metes and bounds;

BEGINNING at a point at the corner of Lot No. 53, which point lies S. 23 W. 286 feet from the West side of Trowbridge Avenue, and running thence N. 55-50 W. 591 feet to an iron pin; thence S. 66-40 E. 58.5 feet to an iron pin, corner of Nichols land; thence with Nichols line, S. 22-20 E. 709 feet to a chestnut Oak Tree; thence in a Northeasterly direction and running in a straight line across branch to the point of beginning, containing 4.4 acres, more or less, and being the same conveyed to me by Cherry Investment Company by deed dated January 23, 1942.

McCall and running thence with the line of Lot No. 52, S. 51-00 W. 120 feet to an iron pin in line of property now or formerly of H. R.
