4. No liquor shall be made or sold on said premises.
5. The Grantees shall make a sanitary disposal of sewerage refuse and shall
not empty same into creeks or streams. 6. It is a part of the consideration for this deed that said property herein
conveyed shall be used for residential purposes only and that no business or commercial
undertaking of any kind or nature whatsoever shall ever be permitted thereon.
The within Grantors, their heirs or assigns, shall not be liable to the
within Grantee, in connection with the operation or maintenance of the roadways, swimming pool,
parks or playgrounds or utilities within Wildwood Park Area.
These restrictions are not intended as conditions subsequent but for the
protection of property owners of Wildwood Park, any of whom shall have the right for their
protection to institute necessary proceedings to enjoin and enforce compliance with same.
