The rights, obligations and remedies of the Lessor and the Lessee respectively with reference to each other and to said premises shall be fixed, determined and governed solely by the provisions of said Lease Agreement, this being a short form of Lease intended to be placed on record and executed by the parties for the purpose, of avoiding the necessity of recording the said Lease Agreement. It is understood and agreed, however, that either party may at any time record the soid Lease Agreement if such party deems it necessary and advisable for its own protection so to do.
