TITLE TO REAL ESTATE

THIRD: That no use shall be made of any lot which, in the opinion of the grantor herein, will constitute a nuisance, or prove in any way noxious or offensive to the neighboring inhabitants, or injure the value of neighboring lots.

FOURTH: That no dwelling house shall be built on the above described lot to cost less than Two Thousand (\$2,000.00) Dollars; that no residence, garage or other outbuilding whatsoever shall be erected on said lot, until and unless the plans and specifications thereto have been submitted to and approved to writing by the grantor herein, or its successors. That no building of any kind shall be erected upon said lot nearer than five feet to either side line or rear line of said lot.

Fifth; That not more than one residence shall be erected on each lot or pracel as shown by said plat, PROVIDED, HOWEVER, that in addition to one residence, there may be erected a garage and servants's quarters, (the plans for which are to be first approved as hereinabove provided) in keeping with the premises, and residence built thereon, of slightly appearance and appropriate location, and not nearer than five feet to any side or back line of any adjoining lot not owned by the owner of the land hereinabove described.

SIXTH: That the grantor herein reserves the right to lay, erect and maintain, or authorize the laying, erecting and maintaining of sewer, gas, and water pipes, electric conduits or pipes, telegraph, telephone and electric light poles, and any other such public utilities, on or in any of the roadways, streets or alleys bordering said property, with connecting links for the same along the back and side lines of the lot above described and to grade, surface, and repair the said roadways, streets and alleys, without compensation to any lot owner for any damage sustained therby.

SEVENTH: That no surface closet or other unsanitary device for the disposal of sewerage shall ever be installed or maintained on the lot herein conveyed, but the grantee covenants and agrees to construct at his or her own expense, prior to the occupancy of any residence on said lot, a septic tank in accourdance with plans and specifications approved in writing by the grantor, and of such size and dimensions as are approved by the Department of Health of South Carolina.
