OPTION

C., its successors and assigns, an option to purchase the real estate hereinafter briefly described, for street purposes in connection with the widening of College Street in the City of Greenville, S. C., the property being briefly described as follows:

Beginning at a point on the southern side of College Street at the joint corner of Manos and Thackston; thence in a westerly direction 107.5 feet to a point at the intersection of the southern side of College Street and the eastern side of Richardson Street; thence along the eastern side of Richardson Street in a southerly direction 17.5' more or less to a point; thence in an easterly direction 105' more or less to a point on the Bessie G. Manos line; thence with the Manos-Thackston line in a northerly direction 6.00' to the beginning point.

The purchase price to be \$1.00 in cash, and the following additional or special considerations, if any:

- 1. That the City of Greenville will reset any existing fence at the direction of the property owner, work to be done by the Anchor Post Fence Company of which Frank P. Cuttino is manager. Said work to be done at the expense of the City of Greenville, S. C.
- 2. That the South Carolina State Highway Department agrees to inconvenience the property owner in carrying on his business only as much as is absolutely necessary for the construction of the street.

C., free from liens and encumbrances for Street purposes, which deed may contain any other unfulfilled duties for agreements to be performed by the grantee.
