Lewis, the present owner of lot No. 15, conveying the same to the Duke Power Company, free and release from all restrictions of every nature, for the purpose of said Duke Power Company constructing, building and maintaining in perpetuity on said lot No. 15 an electric substation for the purpose of providing ample electric power to the owners of the various lots in this sub-division and adjacent properties, and do further hereby consent to the said Duke Power Company, its successors and assigns, constructing on said lot No. 15 an electric sub-station, and maintaining the same irrespective of the restrictions herein before referred to.
