E., and the line then runs N. 26 E. 4026 feet, more or less, to a stake in the North and South Carolina dividing line which stone is 528 feet North of a White Oak, marked, said White Oak being in the dividing line of said States; thence with the meanderings of the said States line in a Southernly direction 528 feet to said White Oak; thence with the meandersings of said States line and in a Southernly direction to a stone in a line that runs from the beginning corner stone S. 76.45 E.; thence along said last mentioned line, reversing the course, N. 76.45 W. 5887 feet, more or less, to	•
