Beginning at an iron pin at the Northeast corner of the intersection of Rutherford and Randall Streets and running thence along and with the East side of Rutherford Street, N. 1-22 E. 283
feet to an iron pin in line of Lot, now or formerly of Dr. J. E. Shaw; thence with his line S. 82-35 E. 200 feet, more or less, to an iron pin on the West side of an alley; thence with said
Alley, S. 1-22 W. 272 feet to an iron pin on the North side of Randall Street; thence along and with the North side of said Street, N. 82-30 W. 200 feet to the beginning.
