Cannon, Sr., and Ernest Tollison, as Trustees for Nelle Alverson (now Nelle Alverson Palmer). All that piece, parcel or lot of land in Ward One of the City of Greenville in the State and County aforesaid, having the following metes and bounds, to-wit:

BEGINNING at a point on Pinkney Street 130 feet from the corner of Frank and Pinkney Streets and running thence on a parallel line with Frank Street 150 feet to the Bridges Line; thence along Bridges line 63 feet to an iron pin; thence on a parallel line with Frank Street 150 feet to an iron pin on Pinkney Street; thence along Pinkney Street 63 feet to the beginning corner.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said Julius H. Cannon, Sr. and Ernest Tollison, as Trustees for Nelle Alverson (now Nelle Alverson Palmer), their successors and assigns forever, for the following uses and purposes, to-wit:
