And together with all buildings (including main building, warehouses, garages, tenant houses and sulphuric acid mixing house), side tracks, spur tracks, water filter plants, water softening plants, pumping stations, storage tanks and other structures located upon the real estate herein conveyed, and all central heating, fire protection and water distribution systems and all other fixtures inseparably attached to the real estate and buildings and structures above mentioned, excepting and excluding, however, all removable machinery including machinery used for bleaching, dyeing, starching, drying, mercerizing, sanforizing, waterproofing, the making of corduroy and otherwise finishing cotton and rayon cloth and complementary machinery and equipment, all of which machinery has previously been transferred by the Grantor to the Grantees.

This conveyance is subject to the rights, if any, of the public or any person, firm or corporation to the use of the streets, roadways or alleys located upon the above described land, it being the intention of the Grantor, however, to convey to the Grantees all of its rights, title or interest in or to said streets, roadways or alleys.

TO HAVE AND TO HOLD all and singular the premises before mentioned unto the Grantees here-inabove named, and their Successors and Assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the Grantees hereinabove named, and their Successors and Assigns, a gainst itself and its Successors, and a gainst every person whom-soever lawfully claiming or to claim the same or any part thereof.
