

TITLE TO REAL ESTATE

THE STATE OF SOUTH CAROLINA, } BY THE SECRETARY OF THE STATE.
EXECUTIVE DEPARTMENT

WHEREAS, Harry L. Jenkins and James D. Henson,
both of 2 Rutherford Road, Greenville, South Carolina,

did on the 18th day of October, 1947, file with the Secretary of State a written Declaration signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed Corporation is HENSON & JENKINS CO.

THIRD: That the principal place of business is GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to buy, sell, distribute and service radios, radio parts, electronic devices, electrical and household appliances; to do electric wiring, repairing, equipping, and to sell and otherwise deal in any allied products and to do and perform any and all acts reasonable and necessary for the conduct of such business and any and all acts allowed a corporation under the laws of the State of South Carolina.

FIFTH: That the amount of the capital stock is One Thousand (\$1,000.00) Dollars,
payable in cash and merchandise.

SIXTH: That the number of shares into which the capital stock is divided is ten (10) Dollars,
of the par value of One Hundred (\$100.00)

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 15th day of October, 1947, at which a majority of all stock in value being present in person or by proxy the following were elected directors:
Harry L. Jenkins and James D. Henson

EIGHTH: That subsequently there was elected as President Harry L. Jenkins
as Vice-President, James D. Henson; as Secretary, James D. Henson
as Treasurer, Harry L. Jenkins

NINTH: That all requirements of Article 2, Chapter 153 Code of Laws of South Carolina, 1932, and all amendments thereto, have been duly and fully complied with, 50 per cent, of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in Greenville Piedmont
a newspaper published in the County of Greenville

NOW, Therefore, I, W. P. BLACKWELL, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
