

All that piece, parcel or lot of land in Greenville

Township, Greenville County, State

of South Carolina, on the East side of McDaniel Avenue near the City of Greenville as shown on a plat made by Dalton & Neves, Engineers, February 1935 and according to a recent survey made by Pickell and Pickell, Engineers, October 1st, 1947, designated as property of H. J. Haynsworth, Jr. and having, according to said recent survey, the following metes and bounds, to-wit:-
