KNOW ALL MEN BY THESE PRESENTS, That I, Next...Henry...trustee... of...
the County of Greenville, in the State aforesaid, in consideration of the sum of ten dollars (\$10.00), and other...
valuable considerations, to...
to...in hand paid at and before the sealing of these presents
by Oscar...L...Davis... (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents
do grant, bargain, sell and release unto the said Oscar...L...Davis...,

all that piece, parcel or lot of land in ----- Greenville ----- Township, Greenville-----
County, State of South Carolina, in that section known as Swis -cudi, about two
miles north of the city of Greenville, on the Franklin road at the
southeast corner of its intersection with Berkley Avenue, said lot
or piece of land having the following lines, courses and distances:-

Beginning at an iron pin on the southern edge of a five (5) foot
sidewalk running along the Franklin road, said pin being the joint
front corner of lots two (2-a) and three a (3 a) as shown on Plat
of said property made by W. J. Middle in November, 1947, recorded in
the Office of Greenville County in Plat Book "A" at page
127, which plat is hereby referred to and made a part hereof;
the running thence S. 80-52 E., one hundred and fifty (150) feet,
to an iron pin; thence S. 19-32 E., fifteen (15) feet, to an iron pin;
rear corner of lot three a (3 a); thence along the eastern line of
lot three a (3 a), S. 78-15 E., one hundred and forty-eight (148)
feet to the beginning corner, said piece of land being triangular
in shape and adjoining the street (.C) foot lot heretofore sold to
the trustee, giving him a frontage on the Franklin road of ninety
(90) feet and a width in the rear of four hundred and five (125)
feet, ~~xxxx~~ making him own overall of lot one (1) and thirty
(30) feet of lot two (2) in addition to the triangular piece of land
conveyed, see also plat record in Plat Book "A" at page
20.

Said property is in a restricted district, and is subject
to the following restrictions, which constitute a part of the con-
tract; therefore, the same shall be effective for a period of twenty-
five (25) years from the date hereof:-

- (1) Said property is to be used for residential purposes only.
- (2) No house shall be erected thereon at a cost of less than
four thousand dollars (\$4,000.00).
