All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville on the east side of Cleveland

Street and being known and designated as a portion of Lots Nos. 1 and 2 as shown on Map No. 2 of Cleveland Terrace and recorded in the R.M.C. Office for Greenville County in Plat Book I, pages 85 and 86 and being more particularly shown and designated as Lots No. 2 and a portion of Lots Nos. 1 as shown on plat by Pickell & Pickell, Engineers dated January 2, 1948 and recorded in Plat Book R, page 143, R. M. C. Office for Greenville County and having the following metes and bounds:

BEGINNING at an iron pin on the east side of a five foot concrete sidewalk which runs along the east side of Cleveland Street, said point being the original southwest corner of Lot No. 2 as shown on the last mentioned plat and running thence S. 89-11 E. 125 feet to an iron pin on an alley; thence with said alley N. 0-49 E. 24.9 feet to a stake; thence N. 89-45 W. 125 feet to a stake on the east side of said sidewalk; thence along the east side of said sidewalk S. 0-47 E. 24 feet to the beginning.
