- 2. That in lieu of the rentals provided in said lease and in the amendment thereof dated July 1, 1947, the said Piedmont Shirt Company agrees to pay to Shepsal Realty Corp. as a rental for said premises the sum of Thirty-seven Thousand Eight Hundred (\$37,800.00) Dollars annually, said rentals to commence the first of April, 1948 and to be payable in equal monthly installments of Thirty-one Hundred Fifty & no/100 (\$3,150.00) Dollars each in advance beginning April 1, 1948 and to continue for each succeeding year until March 31, 1958.
- 3. That said lease as to all other terms and conditions, except as herein modified, shall continue in full force and effect.
