

University Ridge Homes, Inc., its successors and assigns:

All those certain pieces, parcels or lots of land with the buildings and improvements thereon situate, lying and being at the Southwest corner of the intersection of University Ridge and McDaniel Avenue, and being shown as Lots 20, 21 and a strip lying between the rear of said lots and a branch as shown on Map No.2 of Cleveland Terrace. made by Dalton & Neves, Engineers, May 1931, recorded in R.M.C. Office for Greenville County, S. C. in Plat Book K page 98-99, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of University Ridge joint front corner of Lots 19 and 20, and running thence along the line of Lot 19 S. 7-56 E. 207.2 feet to iron pin at rear corner of Lots 19 and 20; thence continuing S. 7-56 E. 21 feet to point in branch; thence down the branch following the meanderings thereof (the traverse line being N. 83-00 E. 221 feet) to a point in center of branch on West side of McDaniel Avenue; thence along the West side of McDaniel Avenue N. 6-53 E. 25 feet to iron pin at corner of Lot 21; thence along a curved line following McDaniel Avenue and University Ridge (the chord being N. 33-37 W. 76.8 feet to an iron pin on the South side of University Ridge; thence continuing with University Ridge N. 53-35 W. 155 feet to iron pin; thence still with University Ridge along a curved line (the chord being N. 61-53 W. 35 feet) to a point; thence continuing with the South side of University Ridge along a curved line (the chord being S. 77-17 W. 55 feet) to iron pin, the beginning corner.
