

C. Sellers and on the southwest by lands of M. S. Poole, and being a part of the same land that was conveyed to me by deed from Mrs. Evelyn Gentry recorded in the office of the R. M. C. for Greenville County in Deed Book 300 at page 295, and having the following courses and distances, to wit :-

Beginning on a stone, joint corner of the Bennefield land and of M. O. Sellers, and runs thence with the Sellers line S. 43-20 \mbox{W}_{\circ} 627 feet to a stone, joint corner of the Sellers aand and of M. S. Poole; thence with the M. S. Poole line N. 23-10 W. 262 feet to a stake on the said line and on the branch; thence up and with the meanders of the said branch as the line in a northeasterly direction to an iron pin on the northern bank of the branch, joint corner of the Bennefield land; thence with the Bennefield line S. 50-15 E. 152 feet to the beginning corner, and containing Two and Seven Tenths (2,7) Acres, more or less.

The grantor herein also gives the grantee herein the right to build a fish pond on the said branch, which is the property line herein, the dam to be build to such height that it will not back water ### more than ten feet from the bank of the said branch.
