SIMS, of Greenville County, South Carolina, his heirs and assigns,

ALL that certain strip, piece or parcel of land situate, lying and being at West Greenville, Greenville County, South Carolina, more particularly described as follows:

BEGINNING at the intersection of the northerly property line of Liberty Street (unopened) with the easterly property line of Lois Avenue; and running thence Northwardly, along said easterly property line of Lois Avenue, a distance of eighty-two and six-tenths (82.6) feet, more or less, to intersection with the dividing line between property of Henry P. Sims and property of R. D. and Maryann Phillips, if extended westwardly; thence Eastwardly, along said dividing line, if extended, and at right angles to said easterly property line of Lois Avenue, a distance of thirteen (13) feet, more or less, to northwesterly corner of property of Henry P.
