R. Know All Men by These Presents:

in the State aforesaid, I, Bernice J. Watson That in consideration of the sum of Three Thousand and No/100- - and assumption of mortgage set out below, --- (\$3000.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John P. Taylor, his Heirs and Assigns forever,

"All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on Paris Mountain Avenue, between Beacon Street and Belmont Avenue, said lot having the following lines, courses and distances,

"BEGINNING at an iron pin on the Southern side of a 5-foot sidewalk running along Paris Mountain Avenue, said pin being the joint front corner of Lots Nos. 22 and 23, and running thence along the Southern edge of said sidewalk, N. 84-28 E. 60 feet to an iron pin, joint front corner of Lots Nos. 21 and 22; thence along the Western line of Lot No. 21, S. 5-35 E. 162.5 feet to an iron pin, joint rear corner of Lots Nos. 21 and 22; thence along the rear line of Lot No. 9, S. 84-28 W. 60 feet to an iron pin in the Eastern line of Lot No. 23; thence along the Eastern line of Lot No. 23, N. 5-35 W. 162.5 feet to an iron pin on the Southern edge of said sidewalk running along Paris Mountain Avenue, the beginning corner; said lot being known and designated as Lot No. 22 on Plat of said property recorded in the Office of R. M. C. for Greenville County in Plat Book "B" at Page 33, which Plat is hereby referred to and made a part hereof."
