RESTRICTIVE AND PROTECTIVE COVENANTS APPLICABLE TO PINEHURST

The following Restrictive and Protective Covenants are hereby imposed on Pinehurst, a subdivision, containing 101 lots, as shown on a Plat recorded in Plat Book S, pages 77, R. M. C. Office for Greenville County, S. C. These covenants and restrictions are imposed not only for the benefit of the grantors but also for the benefit of each and every purchaser of any of the said property, their heirs and assigns. If the parties hereto, their heirs or assigns, shall violate any of the covenants herein, it shall be lawful for any other person or persons owning any real property situated in said subdivision to prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any such covenant or restriction and either prevent him or them from so doing or to recover damage or other dues for such violation.

- 1. No buildings other than a single family residence, except garages, garage apartment or other small buildings used for domestic purposes solely, shall be built, erected, or moved upon said land, except on lots in Block "B" of said subdivision, where multiple family units may be constructed.
- 2. No part of any structure built upon said land shall be nearer to the front property line on any street than thirty feet, or nearer any side property line than five feet.
- 3. No buildings shall be built, erected, or moved upon any lot which has less than sixty feet of street frontage.
- 4. The premises shall not be owned or occupied by Negroes or persons of Negro blood, provided that this shall not be construed to prevent the living upon the premises of any person who is employed for domestic purposes by the occupants of the dwelling on said land.
- 5. No fences which exceed three feet in height shall be built, erected or moved upon the premises nearer than thirty feet from the front property line.
- 6. No residence containing less than 850 square feet, exclusive of porches and garages, shall be built, erected or moved upon lots 1 and 2 of Block "A", lots 1, 2, 3, 4 and 5 of Block "B", and lots 1 and 2 of Block "C".
- 7. No residence containg less than 700 square feet shall be built, erected or moved upon lots 3 through 26, Block "A", lots 6 through 50 of Block "B", lots 3 through 25 of Block "A".
- 8. If not of masonry construction, all structures shall, before being occupied, be painted on the exterior with two coats of paint, nor shall any structure be occupied as a dwelling unless restriction number nine, immediately following, has been complied with. This shall not be construed to mean that an apartment adjoining or above a garage may not be built at any time upon the rear one-third of the premises.
- 9. No outisde toliet, or privy, shall be installed or maintained on the premises, and all plumbing shall be connected with a sanitary sewer or septic tank, which shall at all times be maintained in a proper sanitary condition.
