Hicks, and running thence along said Hicks line, S 31 - 08 W 1846.5 feet to an iron pipe; thence still with said Hicks line, N 67 - 07 W 901.2 feet to a stone by witnessed 30 inch oak, corner of property now or formerly owned by Wilbanks; thence along said Wilbanks property as the line, S 23 - 41 W 885.9 feet to a stone, corner of property now or formerly of Warren Rosemond; thence with said Rosemond property as the line, S 76 - 12 E 2222.8 feet to an iron pin, corner of property of H.
