

Street in Section 6 of Judson Mill Village, being known and designated as Lot No. 44 on a plat of Section 6, Judson Mill Village, made by Dalton & Neves, Engineers, November, 1941, recorded in the R. M. C. office for Greenville County, South Carolina, in Plat Book K, at pages 106 and 107, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of D. Street at the corner of Lot No. 45, which point is 49 feet North of the curvature of the intersection of Fifth Street, and running thence along the East side of D. Street, N. 1-37 W. 70 feet to an iron pin at the corner of Lot No. 43; thence N. 88-23 E. 78 feet to an iron pin; thence S. 1-37 E. 70 feet to an iron pin at the rear corner of Lot No. 45; thence along the line of that lot, S. 88-23 W. 78 feet to the beginning corner.
