

all that piece, parcel or lot of land in Greenville

Township. Greenville

County. State of South Carolina, at the Northeast intersection of the Cedar Lane Road and Smythe street extension, near the City of Greenville, being a portion of Lot 7 and 8 of Block DD, a 5-foot strip off the rear of Lots 1, 2 and 3 of Block DD and a 10-foot strip shown as a 10-foot alley, all as shown on plat of "Riverside", recorded in the R. M. C. office for Greenville County in Plat Book A, page 323 (a 10-foot alley, page 323 (a 10-foot alley). The recorded in Plat Book K, page 281-284) and described as follows:

BEGINNING at a stake at the Northeast intersection of the Cedar Lane road and Smythe street extension, and running thence with the East side of Smythe street extension in a Northerly direction 116 feet to a stake on an alley, opened or to be opened; thence with the line of said alley, S. 79-21 E. 121.8 feet to a stake; thence in a Southerly direction 79 feet to a stake on the Cedar Lane road; thence with the North side of the Cedar Lane Road. S. 85-59 W. 130 feet, more or less, to the beginning corner; together with all my right, title and interest in the said 10-foot alley in the rear of the above lots, opened or to be opened; being the same property conveyed to me by J. W. Henson by deed dated September 22, 1938 and recorded in the R. M. C. office for Greenville County in Deed Vol. 206, page 91 and by deed dated February 17, 1939, recorded in Deed Vol. 217, page 250. This being the remaining portion of Lots Nos. 7 and 8 of Block DD after the re-location of the Cedar Lane road and in addition all of the 10-foot alley in the rear and a 5-foot strip off Lots 1, 2 and 3 of Block DD.

ALSO:- All my right, title, and interest in and to the portion of Lots Nos. 7 and 8 of Block DD, "Riverside", as shown on plat above referred to, which has been covered by the Cedar Lane Road since an easement or right-of-way was granted to the South Carolina State Highway Department over that portion of said lots. For further description thereof, see Judgment Roll E-7265 which is on file in the office of the Clerk of Court for Greenville County.

The above lots are shown on the Township Block Book at Sheet 147, Block 12, Lots 10 and 11, and the grantee is to pay taxes for 1949.
