

All those two lots of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, being known and designated as lots Nos. 40 and 41 of the Eliza T. Looper Property, according to a plat made by R. E. Dalton in December 1924, and when described together, have the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Looper Street, which pin is 152 feet South from Wilson Street, and running thence S. 71-20 W. 157.3 feet to an iron pin, rear corner of lot No. 33; thence with the rear line of lots Nos. 33 and 32, S. 15-42 E. 112.8 feet to an iron pin, corner of lot No. 42; thence with the line of lot No. 42, N. 71 -20 E.144.7 feet to an iron oin on Looper Street; thence with the western side of Looper Street, N. 9-18 W. 114.34 feet to the point of beginning.

Said premises being the same conveyed to the grantor by two separate deeds from Eliza T. Looper - one recorded in Volume 290 at Page 32 and the other by deed recorded in Volume 303 at Page 129.

As a part of the consideration for this deed the grantee assumes and agrees to pay a balance of \$4064.58 due on a mortgage executed by the grantor to Fidelity Federal Savings & Loan Association, recorded in Volume 366 at Page 40.
