to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said George P. Paulos, his Heirs and Assigns forever,

All that lot of land in Greenville Township, on the Southern side of Montclair Avenue (formerly Fairview Avenue), in the City of Greenville, being shown as Lots No. 17 and the Eastern one-half of Lot No. 16 of Block G as shown on a Plat of Highland Terrace, recorded in Plat Book K at Page 120, and described as follows:

BEGINNING at a stake on the South side of Montclair Avenue, 142.6 feet East from Townes Street, and running thence S. 9-52 W. 150 feet to a stake on a 15-foot alley; thence with the Northern side of said alley, S. 80-08 E. 75 feet to a stake at corner of Lot No. 18; thence with the line of said lot, N. 9-52 E. 150 feet to a stake on Montclair Avenue; thence with the Southern side of Montclair Avenue, N. 80-08 W. 75 feet to the beginning corner.
