"BEGINNING at an iron pin on the Northeast side of Cedar Lane Road at joint front corner of Lots Nos. 2 and 3, said pin also being 254.5 feet west from the Northwest corner of the intersection of Cedar Lane Road and Worth Street, and running thence with Lot No. 2, N. 34-0 E. 300 feet to an iron pin; thence with the rear line of Lot No. 18, N. 58-30 W. 100 feet to an iron pin; thence with line of Lot No. 4, S. 34-0 W. 300 feet to an iron pin on the Northeast side of Cedar Lane Road; thence with the northeast side of Cedar Lane Road, S. 58-30 E. 100 feet to the beginning corner."

Said premises being the same conveyed to the Grantor by Rhoda L. Haynsworth, as Trustee by deed dated April 4, 1944, recorded in Book of Deeds 289 at Page 348.

- No residence shall be constructed on this lot nearer than 50 feet to the Cedar Lane Road.
