

All that certain piece, parcel or let of land with the buildings and improvements thereon situate, lying and being on the South side of Potomac Avenue, in that area recently annexed to the City of Greenville, in Greenville County, South Carolina, being designated as Lot 232 on Plat of Pleasant Valley, Section 1, prepared by Dalton & Neves, Engineers, April 1946, recorded in R.M.C. Office for Greenville County, S.C. in Plat Book "P", page 93, and having according to said plat the following metes and bounds to-wit:
