

All that certain piece, parcel or lot of land situate, lying and being on the East side of Carolina Avenue in that area recently annexed to the City of Greenville, in Greenville County, State of South Carolina, being shown as Lot No. 6, Block J, Section 5, on Plat of East Highlands Estates, made by Dalton & Neves, Engineers, February 1941, recorded in Plat Book K, pages 79-80, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Carolina Avenue, at joint front corner of Lots 5 and 6 of Block J, and running thence along the line of Lot 5 N. 83-44 E. 177 feet to iron pin on the West, edge of a 5-foot strip of land reserved for utilities; thence along the West edge of strip of land reserved for utilities S. 0-24 E. 88 feet to iron pin; thence along the line of Lot 7 S. 89-36 W. 175 feet to iron pin on the East side of Carolina Avenue; thence along the East side of Carolina Avenue N. 1-26 W. 70 feet to the beginning corner.
