

all that piece, parcel or lot of land in Chick Springs

County, State of South Carolina, on the east side of an unnamed street near the City of Greenville, South Carolina, being known as Lot No. 7 and the northern portion of Lot No. 1, on a plat of the property of E. E. Foister, recorded in the m. N. C. Office for Greenville County, South Carolina, in Plat Book J, at Fame 159, and being described as follows:

BEGINMING at the joint corners of Lots Nos. 1 and 7 on said unnamer strept, and running thence N. 33-0 E. 96 feet to corner of Lot No. 7 and said unnamed street; thence with line of Lot No. 7 S. 53-40 E. to a point; thence D. 6-30 . 100 feet to joint corner of Lots Nos. 1 and 7; thence N. 57-0 ... 106 feet to the beginning corner; this being all of Lot No. 7 as shown on said plat.
