

All that lot of land in Greenville Township, Greenville County, State of South Carolina, partly in and partly out of the City of Greenville, on the North side of May Avenue, and being shown as Lot No. 9 on Plat of property of Barmore Realty Company made by J. C. Hill May 15, 1949, recorded in Plat Book V at . Page 153, and described as follows:

BEGINNING at a stake on the Northern side of May Avenue 268.5 feet East from Pinckney Street, at corner of Lot No. 7, and running thence with the line of said lot, N. 32-30 W. 62 feet to a stake; thence N. 57-30 E. 61 feet to a point on bank of Pond; thence with the line of said Pond, a distance of 63.9 feet, the chord of which is S. 32-30 E., to a stake on May Avenue; thence with the Northern side of May Avenue, S. 57-30 W. 61 feet to the beginning corner.
