County, State of South Carolina being Tract No. 2 of the division of Albert C.
Kelly, deceased, according to a plat made by J. H. Cox, surveyor, Jan.
4th & 5th, 1904, recorded in the R.M.C. Office for Greenville County
in Plat Book "V" page 191, and having according to said plat the
following metes and bounds to-wit:

BEGINNING at a stone in road, in line of Tract No. 1, and running
thence with line of Tract Number 1, S. 51° W. 66.50' chains to
a stone 3xm; thence S. 72° W. 12' chains to a stone 3xm, I.
Jordan corner; thence with Jordan line S. 15° W. 6' chains to a
stone 3xm.; thence N. 72° E. 15.50' chains to a stone 3xm (stone
gone); thence S. 10° W. 11.12' chains to a 3xm, I. Alberson
corner; thence with Alberson line S. 54° W. 15.50' chains to
stone 3xm. 31. Oak gone, corner on side of road; thence with said
road N. 36° E. 10.72' chains; thence still with said road N. 26° E.
8.10' chains to an angle in said road; thence still with said
road N. 10° E. 10.80' chains to a stone 3xm; thence S. 33° E. 22.25'
