

ALL that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, being known and designated as a part of the subdivision of the Property of Putman & Craft, known as Hodgens Estate, plat of which is recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "S" at page 47, and being more particularly described as follows:
