

KNOW ALL MEN BY THESE PRESENTS, That I, Hext. M. Perry, Irustee, of the
County of Greenville,
in the State aforesaid, in consideration of the sum of ten dollars. (\$10.00), and .other. valu

by . Alvin Y. Rosamond, Jr.,
(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these
presents do grant, bargain, sell and release unto the said. Alvin Y. Rosamond, Jr.,

County, State of South Carolina, on Darlington Avenue between Dykeson Avenue and Duckert Street, in the San Souci section of Greenville County, about two miles north of the City of Greenville, said lot having the following lines, courses and distances, to wit:-

Beginning at an iron pin on the southern edge of a five (5) foot sidewalk running along Darlington Avenue, said pin being the joint front corner of lots numbered ten (10) and eleven (11); and running thence along the southern edge of said sidewalk, N. 29-39 E., sixty-one and eight tenths (61.8) feet, to an iron pin, joint front corner of lots eleven (11) and twelve (12); thence along the western line of lot twelve (12), S. 47-0 E., one hundred and ten and two tenths (110.2) feet, to an iron pin, joint rear corner of lots eleven (11) and twelve (12); thence S. 43-0 W., sixty (60) feet, to an iron pin, joint rear corner of lots ten (10) and eleven (11); thence along the eastern line of lot ten (10), N. 47-0 W., ninety-six (96) feet, to an iron pin, the beginning corner, said lot being known and designated as lot numbered eleven (11) on Plat of said property recorded in the Office of the Register of Mesne Conveyance for Greenville County in Plat Book "U" at page 121, which Plat is hereby referred to and made a part hereof.

Said property is in a restricted district, and is sold subject to the following restrictions, which constitute a part of the consideration therefor, and shall be effective for a period of twenty-five (25) years from the date hereof:-

- (1) Paid property shall be used for residential purposes only.
- (2) No residence shall be erected thereon at a cost of less than four thousand dollars (\$4,000.00.\$).
- (3) No house shall be erected thereon nearer the southern edge of said sidewalk running along Darlington Avenue than twenty (20) feet.
  - (4) Said property shall not be sold to any person of African descent.
