These restrictions are not intended as conditions subsequent but are for protection of the adjacent property owners of Wildwood Park This conveyance is made subject to the right of Edwin McT Meares, his heirs or assign to enter upon the above described property for the purpose of containing an uninterupted flow of water along the stream which leads to his property. This conveyance is subject to such rights as may have heretofore been granted by the grantor herein to any property owner in Wildwood Park.
