All that piece, parcel or lot of land in Austin Township, Green-ville County, State of South Carolina, containing 98 acres, more or less, bounded by lands of J. A. Tolbert on the North; lands of J. Watts and R. Rowley on the East; lands of Jim Pickett and L. B. Hendrix on the South; and lands of A. H. Dean and Roy McBee on the West, all of which is fully set out upon plat of same by W. J. Riddle, Surveyor, dated June 24th, 1922.
