

George W. Hester, his heirs and assigns, forever:

All that certain piece, parcel or lot of land in Paris Mountain Township, County and State aforesaid, lying on the West side of Haynsworth Road and being known and designated as a part of Lot #18 of the Farr Estates, as shown on plat recorded in Plat Book "M", Page 19, R. M. C. Office for Greenville County, S. C., and being further known and designated as Lot #1, according to plat of property of J. K. Keller, made by W. J. Riddle, Surveyor, April, 1949, and having the following metes and bounds, according to said plat.

BEGINNING at an iron pin on the West side of Haynsworth Road, corner of property now or formerly of W. A. Helton; thence with his line, S. 61-0 W. 370 feet to an iron pin; thence S. 60 W. 25 feet to an iron pin; thence with property now or formerly of Mulkey, S. 55 E. 109 feet to an iron pin in line of property of Frances Louise Watson; thence with her line, N. 56-32 E. 336 feet to an iron pin on Haynsworth Road; thence with said Road, N. 17 W. 70 feet to the beginning.


