

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the City of Greenville, and Allandate Expression Allandate County, States and Allandate County States and Allandate

according to a plat of property of James A. Moody, made by Pickell and Bishafi Cardingineers, August 4, 1945, described as follows:

BEGINNING at a stake on the Southern side of Laurens Road, 64.7 feet East from Haviland Avenue, at corner of other property of the said James A. Moody, and running thence with the Southern side of Laurens Road, S. 72-45 E. 44 feet to an iron pin, corner of Golightly property; thence with line of said property, S. 22-15 W. 87 feet to an iron pin in line of the Evans property; thence with line of said property, N. 70-30 W. 44 feet to stake, corner of other property of James A. Moody; thence with line of said property, approximately N. 22-15 E. 87.2 feet, more or less, to the beginning corner, being the Eastern 44 feet of the lot conveyed to James A. Moody by J. T. Solomons, Jr., as Administrator, et al, by deed recorded in Book of deeds 279 at page 56, and the same tract of land conveyed by James A. Moody to G. D. Roberson by deed dated November 20, 1945, and recorded in Deed Book 287 at page 443, and being the same lot of land conveyed to the grantor by Annie A. Fowler by her deed dated the 29th day of July, 1949 and recorded in the R. M. C. Office for Greenville County in Deed volume 387 at page 515.

ALSO: All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina just outside of the City of Greenville on the South side of Laurens Road, and having according to survey and plat prepared by Pickell and Pickell, Engineers, August 4, 1945 the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the South side of Laurens Road, which pin is 64.7 feet from the Southeast intersection of Haviland Street and the said Laurens Road and on the joint corner of lot conveyed byxem to G. D. Roberson by deed recorded in Vol. 267, page 443, R. M. C. Office for Greenville County and running thence S. 22-15 W. 87 feet to iron pin, joint corners of this lot with the Roberson lot in the rear; thence N. 70-30 W. 24.2 feet to iron pin, the joint corners of this lot and the Vaughan lot; thence N. 21 E. 87.3 feet to iron pin on the South side of Laurens Road; thence with Laurens Road S. 72-45 E. 26.2 feet to the point
