

All that piece, parcel, or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 12, as shown on plat of property of Ruth G. Butler, near Paris School, made by W.J.Riddle, Surveyor, in August 1946, and recorded in the R.M.C. Office for Greenville County in Plat Book Q, at Page 1, and having the following metes and bounds, to wit:

BEGINNING at an iron pin on Southeast side of un-named street at joint front corner of Lots 13 and 12, and running thence along Southeast side of said street S. 45-45 E. 100 feet to an iron pin at corner of Lot No. 11; thence along line of said Lot No. 11 S. 42-30 W. 225 feet to an iron pin at rear corner of Lot No. 3; thence along line of said Lot No. 3 N. 45-45 W. 100 feet to an iron pin at rear corner of Lot No. 13; thence along line of said Lot No. 13 N. 42-30 E. 225 feet to the beginning corner.

This is the same lot of land conveyed to the grantors by Ruth G. Butler by deed dated June 28, 1949, recorded in the R.M.C. Office for Greenville County in Deed Book 386, Page 134.

The street above referred to is now known as Hudson Street.
