All that certain piece, parcel or 'ract of land, containing 4.91 acres, more or less, situate, lying and being in Greenville County, State of South Carolina, being shown as Part of Tract No. 8 and Part of Tract No. 7 on Plat of Estate of Vance Edwards prepared by Dalton & Neves, Engineers, in December 1946, recorded in Plat Book P, at page 128-129 (revised plat of which is also recorded in Plat Book P, page 204-205) R.M.C. Office, Greenville County, S.C., and having according to a recent survey by Dalton & Neves, Engineers, in October 1949, the following metes and bounds, to-wit:
